

3. Query: The Person and Redemptive Work of Jesus Christ

Whereas: We Brethren have sought to define ourselves as those who are “continuing the work of Jesus...;” and,

Whereas: a faith commitment to Jesus Christ as Lord and Savior has served as a pre-requisite for believers’ baptism as well as for ordination within our denomination; and,

Whereas: the 1991 Annual Conference passed the query, *Religious Pluralism and the Headship of Christ*, stating that “the Annual Conference of the Church of the Brethren affirms that Jesus Christ is the son of God, Savior of the World, and Head of the Church according to the Scriptures;” and,

Whereas: this statement was affirmed at the 1995 Annual Conference in the query, *Ordination/Lordship of Christ*, and was strengthened stating “that not only all members, but especially those called to a set apart ministry, should affirm the uniqueness of Jesus Christ as the only divine Lord and Savior;”, and,

Whereas: the 1998 Annual Conference, in its adoption of The New Testament as Our Rule of Faith and Practice Study Committee’s report, stated that our allegiance to the New Testament “requires us to give attention to and hold in equal importance faith and practice—what we believe and how we live it—and continues to hold scripture as the authoritative basis for both;” and,

Whereas: the Annual Conference has made theological statements on other issues, especially as they relate to the practice of our faith, but has yet to give a clear theological statement regarding the person and work of Jesus Christ; and,

Whereas: material produced in recent years by agencies of the Church of the Brethren have brought confusion and hurt within the denomination because of the lack of clarity on the person and work of Jesus Christ.

Therefore we, the Eaton Church of the Brethren of Eaton, Ohio gathered in church council on August 18, 2002 approved asking the Annual Conference, through the Southern Ohio District, to develop a statement that articulates the church’s position on the person and redemptive work of Jesus Christ.
