### Covenant for ALL Attendees

A covenant symbolizes shared responsibility and commitment between two or more persons. In attending National Junior High Conference, all youth, advisors and staff must enter into a covenantal relationship as part of the National Junior High Conference community. The spirit of this covenant is to foster consistent and responsible participation at National Junior High Conference. Failure to comply with the covenant may result in you leaving the conference at your own expense.

As a participant at National Junior High Conference I agree to:

1. Be sincere in my motives for attending National Junior High Conference and to make foremost the goals of personal growth and Christian fellowship.
2. Attend all worship services, workshops and other organized activities.
3. Refrain from using or possessing any controlled substances (i.e. alcohol, tobacco products), illegal drugs or weapons while at National Junior High Conference.
4. Not participate in any behavior that endangers conference participants.
5. Not be in the housing of the opposite gender at any time.
6. Be in my room by curfew each night.
7. Follow the rules of Elizabethtown College.
8. Not leave grounds except for dinner on Friday night and even then, only with the accompaniment of my adult advisor.
9. Follow all other rules set by the National Junior High Conference staff.

### Advisor Covenant (In addition to the Covenant for ALL Attendees)

As an advisor at National Junior High Conference:

1. I understand that I am a **care-taker of children**.
2. I will make sure all the youth for whom I am responsible are in their assigned rooms by curfew.
3. I understand that as an adult I am responsible for the safety and conduct of all youth, even those I did not bring, if I see inappropriate behavior while their advisor is not present
4. I understand that there is a clear **power difference** between myself and the youth (money, mobility, authority, experience, knowledge, different set of rules).
5. I understand that inappropriate sexual contact with or physical abuse of a youth can have severe emotional and psychological effects on that youth that can last a lifetime. These reactions can be so severe, they can require intensive professional intervention which is disruptive to the victims' life, as well as time consuming and expensive.
6. Furthermore, I am attesting to the fact that I have read over, understand and accept the rules, guidelines and standards of conduct outlined in this document. I attest that I have never been convicted of child abuse.
